JobCentral National Labor Exchange is provided as a public service by [leading U.S. employers](#) in alliance with The National Association of State Workforce Agencies (NASWA) and participating states.

JobCentral uses an "indexing" process to identify links to jobs on corporate web sites. Job seekers who click on a job title on the search results page are taken directly to the job listing on the corporate web site. This is essentially the same process that is used by all high-level Internet search engines.
